5. A drill was held at the Commerce Center. The focus of the drill was pump operations.
6. We participated in a birthday drive-by for Joe Medio.
7. We have working on ways to continue to build the membership
8. JK called Babbit regarding work on the display sign, there has been no response.
9. Covid 19 update- the State of NJ will go to level 2 on June 15.
10. Fit testing has been done by FF1. At that time FF1 fixed 2 air packs for free.
11. Chief JK explained the TangoTango communication system which uses cell phones to provide push-to-talk communication.
